## **VENDOR APPLICATION RULES**

**WE ARE GRATEFUL FOR YOUR INTEREST IN PARTICIPATING IN THE ANNUAL SANGER SELLABRATION HELD IN DOWNTOWN SANGER ON SATURDAY OCTOBER 28, 2023 WITH ACTIVITIES: 8AM TO 5PM. RETURN VENDOR APPLICATION AND APPLICABLE FEES TO THE SANGER AREA CHAMBER OF COMMERCE BY OCTOBER 20, 2023.**

**THE SANGER AREA CHAMBER OF COMMERCE HAS WORKED HARD ON PROVIDING A FUN AND SUCCESSFUL SELLABRATION. IN DOING SO, WE ASK THAT ALL VENDORS BE AWARE OF, AND IN AGREEMENT WITH THE FOLLOWING GUIDELINES.**

1. Booths and spaces are rented and assigned on a "first come, first serve" basis after full payment is received. Direct sale vendors will be limited to two each (i.e., Scentsy, Tupperware, color street, etc.). Deadline for entry forms and fees is October 20, 2023.
2. The wireless internet will be available to you by Nortex communications. Neither the Chamber of Commerce nor Nortex Communications will be held responsible for any Wi-Fi issues between your equipment and the internet provided.
3. Arts and crafts should be "handcrafted".
4. Sanger Sellabration will be held regardless of weather. No refunds will be made.
5. This event is combined with "safe spook" which allows children to trick or treat. Vendors have the option to participate or not. If you do participate, please plan on having trick or treat items available to give out. No grab and go containers! Signs will be provided to participating vendors identifying you as a trick or treat location. Attendance for this portion of the event would be approximately 500 kids and is scheduled for 2:30pm to 5pm.
6. **Booth set up may begin after 5:00 am Saturday, October 28, 2023** and must be completed/ready for business by 8:00 am.
7. Sanger area chamber of commerce is not responsible for theft or vandalism.
8. Please do not begin to dismantle displays prior to 5 pm on the day of the event. The breakdown of booths must be completed by 5:30 pm. This rule will be strictly enforced for safety reasons.
9. The chamber reserves the right to refuse vendor/exhibits which would in any way distract from the dignity of the event.
10. The chamber reserves the right to stop or remove from the event any individual or exhibitor performing any act or practice which, in the opinion of the chamber, is objectionable, interferes, or creates a health, safety or fire hazard.
11. All vendors/exhibitors are expected to conduct themselves in a polite and professional manner. Any unruly conduct, refusal to follow rules, or use of foul language to event patron or event personnel will be considered grounds for expulsion from the event.
12. All items to be sold must be listed on the vendor application. Selling merchandise not pre-approved or deemed inappropriate for sale to children will be grounds for booth closure.
13. The chamber is not responsible, nor will it arrange to provide any kind of labor for installation, removal or servicing of vendor/exhibit booth.
14. All booths must use weighted tie downs and supports; use of stakes driven into the ground, pavement or concrete is prohibited. The chamber will not provide weights to those vendors who utilize a chamber canopy/tent.
15. A health permit is mandatory for all vendors selling food prepared on site.
16. You will be held responsible for any trash and/or debris resulting from your booth.
17. By submitting the application, the vendor will indemnify and hold harmless SACC from any and all claims, actions, and judgments, including all costs of defense and attorney's fees incurred in defending against same, arising from and related to utilization of a vendor booth area located on /or around Bolivar St downtown sanger, TX during the Sellabration event held on October 28, 2023. Vendor's actions include the acts of vendor's agents, employees and/or guests.
